Ordinance No.30

Parking Restrictions

The Village board of the Village of DeSoto do ordain as follows:

SECTION 1. Except as noted in Sec. 2 below, no person shall park any object or motor vehicle on any street in the village of DeSoto for a period longer than 48 consecutive hours.

SECTION 2. Winter parking regulations will be in effect from December 1 to April of each year. During this period, no person shall park any object or motor vehicle on the South side of Main Street from US Highway 35 East to DeSoto Street on even days of the month between the hours of 2:30 A.M. and 6:30 A.M., and further, no person shall park any object or motor vehicle on the North side of Main Street from US Highway 35 East to DeSoto Street on uneven days of the month between the hours of 2:30 A.M. and 6:30 A.M. In addition and as to all other streets other than that portion of Main street above set forth for that period of time from December 1 to April 1, no person shall park any object or motor vehicle for a period of time in excess of 24 consecutive hours and for not more than a period of 12 consecutive hours after a snow fall of two (2) inches or more.

SECTION 3. Handicapped parking space(s) shall be designated and properly marked. Spaces so designated are as follows:

- Two parking spaces in parking lot by Community Center
- One parking space at the Boat Landing parking lot
- One parking space at 115 Houghton St.
- One parking space at 105 Church St.
- One parking space at 265 Main St.

SECTION 4. Any vehicle or object parked or left standing on a Village street in violation of any of the provisions of this ordinance is declared to be hazard to traffic and public safety. Such vehicle or object shall be removed to a position where parking is not prohibited upon request of any police officer or Village trustee. Any police officer or Village trustee, after issuing a citation or letter of warning for a violation of this ordinance is authorized to remove such vehicle or object to a position where parking is not prohibited. The officer or trustee may order a motor carrier holding a permit to perform vehicle towing services, a licensed motor vehicle salvage dealer or a licensed motor vehicle dealer who performs vehicle towing services to remove and store such

vehicle or object to any storage garage or rental parking ground or any facility of the person providing the towing service. In addition to other penalties provided, the owner or operator of the object or vehicle so removed shall pay the cost of towing and storage. The Village shall not be liable for damages to objects or vehicles removed, towed or stored as a result of the enforcement of this ordinance.

SECTION 5. Any person who violates any provision of this ordinance shall, upon conviction thereof, forfeit not less than \$1.00 nor more than \$500.00 together with the costs of prosecution and in default of payment shall be imprisoned in the County Jail until said forfeiture and costs are paid but not exceed 90 days.

Any person found guilty of violating this ordinance or any part of this ordinance who shall previously have been convicted of violation of the same ordinance shall upon conviction thereof forfeit not less than \$10.00 nor more than \$500.00 for each such offense together with the costs of prosecution and, in default of payment of such forfeiture and costs, shall be imprisoned in the County Jail until said forfeiture and costs of prosecution are paid, but not to exceed six (6) months.

SECTION 6. This Ordinance shall take effect from and after its passage and publication as required by law.
