A. OPEN FORUM: DISCUSSION ON SEWER RATE INCREASE

Jamey Makepeace addressed the residents present: Dave Bean & Jim DelMedico-Frontier Property Management, Kim & Tim Bohnenkamp, Jerry & Kathy Boardman, Linzi Gronning & Dave O'Mara-De Soto Area School District

Jamey Makepeace explained the problems with the sewer system which lead up to the replacement of the sewer main project. The project is costing a total of \$628,000. A CDBG Grant in the amount of \$314,000 is covering ½ the cost. A grant from the Clean Water Fund is covering approx. \$144,456. The remaining amount owed from the project will be taken out in a low interest loan at a rate of 1.76% for 20 years from the Clean Water Fund. Jamey Makepeace explained the project with a sanitary sewer plan profile, project maps and construction details. He answered resident's questions.

The Sewer rate will be going up from \$32 an REU to \$35.75 an REU to cover the Clean Water Fund Loan as shown in the revised Appendix A, Ordinance #38 De Soto Sewer Use Ordinance.
