Jamey discussed the analysis of the bid, references of G-Pro, equipment list, satisfaction with this company, and his recommendation to award the bid to the lowest bidder, G-Pro Excavating, Montfort WI in the amount of \$450,020.00.

Project #1=243,000.00, Project #2=250,900.00 and Project #3=436,815.00. Mill Park Drive now has drainage problems because of all the flooding. The village board will consider this project at the next board meeting.
