#### B. DOT YEAR 2022 PROJECT: FINANCIAL AGREEMENT-DENNIS PARSLEY REP.

Dennis Parsley and Jaime Baodo were present to explain the DOT plan for 2022-2024. Presently there are three options: 1. Do nothing with the parking lanes

- 2. 1 ¾ inch mill and replacement on parking lanes \$25,200.00
- 3. 4 inch mill and replacement on parking lanes \$57,600.00

The adjustment of the sanitary manholes would be paid for by the village as part of the milling operation. There will be two agreements: The Financial Agreement and The Maintenance Agreement. There was discussion on present road conditions in the area. There was a consensus that the roads in this area are in dire need of repair. A request to move the speed limits signs east on Hwy 82 was discussed. The concerned citizens would like the 25 m.p.h. sign moved further east. The cars are not slowing down soon enough and it's causing problems with school children. The village will need to take action on this. The village will need the support of law enforcement.
