A. FLOOD IMPROVEMENT MILL PARK DRIVE SUBDRAIN PROJECT UPDATE

The contractor, H. James and Sons want to start he project on July 8th. We will hold a preconstruction meeting on June 28th or July 2nd. We have a one year warranty to finish work.

C. UPDATE ON FINAL COMPLIANCE ALTERNATIVES PLAN FOR PHOSPHORUS LIMITS

The village sewer department will start incurring charges April 2020 for phosphorus. We can perform a Chemical Addition pilot. The chemical costs approximately \$3.00 a gallon. We would add 1 gallon a day for 30 days then try 2 gallons a day for 30 days. We need to purchase pump tubing, chemicals and a phosphate colorimeter. Steve and Carrie can order this equipment. An approximate 25% increase in sludge will occur with this chemical addition.

Motion made by Timothy Gillespie, seconded by Scott DuCharme to approve spending \$1,500.00 to purchase pump tubing, chemicals and colorimeter. Motion carried.

We need to start the pilot as soon as possible. The PERF is due October 2019. We need an engineering report in a couple of weeks. Motion made by Timothy Gillespie, seconded by Scott DuCharme to allocate 2,500.00 for an engineering report on phosphorus mitigation. Motion carried.

Brief discussion on moving the Bluffside Mobile Home Trailer Court and raising the elevation of Cottonwood Park by filling it in with dredge material from The Army Corp of Engineers. Discussion on sewer hook-up with Village of Ferryville. Cost estimates were handed out. Income surveys need to be performed.
