- 6) Questions may be presented and become part of a discussion or agenda item at the next village board meeting if requested and appropriate for board discussion and action
- 7) No action will be taken on public participation comments during the "Public Comment" agenda line. Items for discussion may be placed on a future board agenda
- 8) Village Board members may respond to questions or information requests personally or in writing following the meeting
